

East Donegal Township LST Quarterly Tax Return

Effective January 1, 2008, all employers with work sites within East Donegal Township are required by law to deduct a Local Services Tax (LST) in the amount of \$52.00 from each employee employed at its work site(s) in East Donegal Township, including owners, self-employed and sole proprietors. If an employee will earn less than \$12,000.00 in gross wages and net profits for the calendar year, the employee can complete an upfront exemption certificate and must submit said certificate to his or her employer and East Donegal Township. The LST Quarterly Remittance must be remitted to East Donegal Township at the address indicated 30 days following the end of each quarter. NOTE: The LST must be deducted from an employee's paycheck on a pro-rata basis determined by the number of payroll periods established by an employer for the calendar year. For example, if paid biweekly or 26 times annually, the employer must deduct \$2 per pay period.
